



The fall of communism in Europe is now the frame of reference for any mass mobilization, from the Arab Spring to the Occupy movement to Brexit. Even thirty years on, 1989 still figures as a guide and motivation for political change. It is now a platitude to call 1989 a "world event." but the chapters in this volume show how it actually became one.

The authors of these nine essays consider how revolutionary events in Europe resonated years later and thousands of miles away: in China and South Africa, Chile and Afghanistan, Turkey and the USA. They trace the circulation of people, practices, and concepts that linked these countries, turning local developments into a global phenomenon. At the same time, they examine the many shifts that revolution underwent in transit. All nine chapters detail the process of mutation, adaptation, and appropriation through which foreign affairs found new meanings on the ground. They interrogate the uses and understandings of 1989 in particular national contexts, often many years after the fact. Taken together, this volume asks how the fall of communism in Europe became the basis for revolutionary action around the world, proposing a paradigm shift in global thinking about revolution and protest.





This book is the culmination of twenty years of research in which the editors gathered thousands of pages documenting the most important conversations of the late Cold War. Every word Ronald Reagan and Mikhail Gorbachev said to each other in their five superpower summits from 1985 to 1988 is included in this volume. The editors argue in their contextual essays and detailed notes that these summits fueled a learning process on both sides of the Cold War. Their anthology provides insight into the nuanced shifts of monumentally important discussions, showing how Moscow's sense of threat was eased and how a hawkish Reagan softened his tone in negotiations during his second presidential term. Documents from foreign ministers Eduard Shevardnadze and George Shultz offer a particularly intriguing look into the handful of conversations that ended almost half a century of conflict.

These verbatim transcripts, until now top secret, are combined with fascinating photos and crucial information from declassified preparatory and after-action documents from both the Americans and Soviets, obtained in the US through the Freedom of Information Act and in Russia from the Gorbachev Foundation, the State Archive of the Russian Federation in Moscow, and from the personal files of Anatoly Chernyaev, Gorbachev's foreign policy adviser.





This book presents and interprets archival records of the meetings between Mikhail Gorbachev and George W. Bush between 1989 and 1991, including transcripts of conversations between top leaders on the rapid and monumental events of the final days of the Cold War. Particularly effective interlocutors were the foreign ministers Eduard Shevardnadze and James Baker, especially interesting when they interacted directly with Bush or Gorbachev. The documents were obtained from the Gorbachev Foundation and the Russian State Archives and from the United States government through requests under the Freedom of Information Act.

Taking place at a time of revolutionary change in Eastern Europe, stimulated in part by Gorbachev and by Eastern Europeans (the Solidarity movement, dissidents, reform communists), the Malta Summit of 1989 and subsequent meetings helped defuse any potential for superpower conflict. Each of the five summits is covered in a separate chapter, introduced by an essay that places the transcripts in historical context. The anthology offers a fascinating glimpse into the relationship that defined the last, waning years of the Cold War—a unique record of these historic, highest-level conversations that effectively brought it to a close. The quality and scope of the dialogue between these world leaders was unprecedented and is likely never to be repeated.



Labor regimes under communism in East-Central Europe were complex, shifting, and ambiguous. This collection of sixteen essays offers new conceptual and empirical ways to understand their history from the end of World War II to 1989, and to think about how their experiences relate to debates about labor history, both European and global.

The authors reconsider the history of state socialism by re-examining the policies and problems of communist regimes and recuperating the voices of the workers who built them. The contributors look at work and workers in Albania, Bulgaria, Czechoslovakia, the German Democratic Republic, Hungary, Poland, Romania, and Yugoslavia. They explore the often contentious relationship between politics and labor policy, dealing with diverse topics including workers' safety and risks; labor rights and protests; working women's politics and professions; migrant workers and social welfare; attempts to control workers' behavior and stem unemployment; and cases of incomplete, compromised, or even abandoned processes of proletarianization. Workers are presented as active agents in resisting and supporting changes in labor policies, in choosing allegiances, and in defining the very nature of work.



Psy-sciences (psychology, psychiatry, psychoanalysis, pedagogy, criminology, special education, etc.) have been connected to politics in different ways since the early twentieth century. Here, in twenty-two essays, scholars address a variety of these intersections from a historical perspective.

The chapters include such diverse topics as the cultural history of psychoanalysis, the complicated relationship between psychoanalysis and the occult, and the struggles for dominance between various schools of psychology. They show the ambivalent positions of the "psy" sciences in the dictatorships and authoritarian regimes of Nazi Germany, East European communism, Latin-American military dictatorships, and the South African apartheid, revealing the crucial role of psychology in legitimating and "normalizing" these regimes.


The authors also discuss the ideological and political aspects of mental health and illness in Hungary, Germany, post-World-War-I Transylvania, and Russia. Other chapters describe the attempt by critical psychology to understand the production of academic, therapeutic, and everyday psychological knowledge in the context of the power relations of modern capitalist societies.



Despite an increase in the number of EU and government initiatives in their favor, the situation of Roma in Europe has only worsened. This book explores the many miscalculations, misconceptions, and blunders that have led to this failure. For Hungary, the Czech Republic, and Romania, Rostas shows how policy makers in each country mishandled already confused EU policy, from failing to define "Roma" to not having a way to evaluate their own progress. Rostas further argues that the alleged successes of these policies were the product of poor information and sometimes outright deception. Examining perennial topics among Roma like school segregation and political representation, the author shows how often the so-called success of Roma policies can be fallacious and simply pave the way for further problems.

Rostas maintains that when the EU's Framework for Roma program comes to an end in 2020, there must be a fundamental shift in policy for there to be any real improvement for Roma. Policy makers will have to address Roma issues not only in terms of poverty and social exclusion but also in terms of the particular nature of Romani ethnic identity. This shift requires reconceiving Roma as a "politically insular minority" and rearranging the power dynamics of local government to ensure that when the new era of Roma policy begins Roma themselves will have a voice in its formulation.



The tumultuous history of the Balkans has been subject to a plethora of conflicting interpretations by local as well as non-Balkan historians. In an attempt to help overcome the stereotypes that still pervade Balkan history and historiography, *Battling over the Balkans* concentrates on five principal controversies from the precommunist period: 1) pre-1914 Ottoman and Eastern Christian Orthodox legacies; 2) post-1918 struggles involving state-building; 3) in the interwar period, the effect of European economic and cultural influence, as opposed to diplomatic or political intervention; 4) in the same period, the role of violence and paramilitary forces in challenging political regimes; and 5) before, during and subsequent to World War II, the fate of ethnic minorities, particularly Jews, Muslims, and Roma.

To give a voice to eminent local authors, the chapters provide samples of new regional scholarship exploring these contested issues—most of them translated into English for the first time. They are prefaced with historiographical overviews addressing the state of the debate on these controversies. These translations help bridge the language gaps that so often separate scholarly traditions within Southeast Europe, as well as those between Southeast Europe scholars and English-speaking academics.





The economic crisis of 2008–2009 signaled the end of the post-Washington consensus on restricting the role of the state in economic and development policy. Since then, state ownership and state intervention have increased worldwide. This volume offers a comparative analysis of the evolution of direct state intervention in the economy through state-owned companies in Austria, Brazil, France, Germany, Hungary, Poland, Turkey, Singapore, and Slovenia. Each case study includes substantial explanations of historical, cultural, and institutional contexts.

All the contributors point to the complex nature of the current revival in state economic interventions. The few models that are successful cannot hide the potential problems of excessive state intervention, linked to high levels of moral hazard. State-owned enterprises are primary tools of market and price manipulation for political purposes. They can be used outright for rent seeking. Yet state-owned enterprises can also play important roles in prestigious national initiatives, like major public works or high-profile social and sports events. The authors conclude that after the uniform application of democratic market economic principles, the 2000s witnessed a path-dependent departure from standard economic and political operating procedures in developed countries.





Transnational Perspectives in Gender Studies

In an era of increased mobility and globalization, a fast growing body of writing originates from authors who live in-between languages and cultures. In response to this challenge, transnational perspective offers a new approach to the growing body of cultural texts with an emphasis on experiences of migration, transculturation, bilingualism, and (cultural) translation.

The introductory analysis and the fifteen essays in this collection critically interrogate complex relations between transnational and translation studies, bringing to this dialogue a much needed gender perspective. Divided into three parts (From Transnational to Translational; Reading Across Borders and Transnational in Translation), they address a range of issues relevant for this debate, from theoretical problems to practical questions of literary criticism and translation, understood as an act of cultural interpretation.

The volume mostly deals with contemporary literary and cultural production, but also with classical texts and modernist literature. Its particular quality is a strong (although not exclusive) focus on Central and East European literatures, and more generally on women writers. Its interdisciplinary, transnational, and intercultural perspective makes it relevant across disciplinary boundaries, from literary and translation studies to gender studies, cultural studies, and migration studies.



The thirteen papers in this collection address three aspects of higher education, primarily in Europe but also in the United States. These aspects are *competition, collaboration*, and *complementarity*, both on the level of policy and on the practical level of impact on students and staff. *Competition*, especially for funding, occurs between and within institutions. *Collaboration*, more than a basic code of conduct, has become a political principle across Europe. *Complementarity* in the market for higher education facilitates this collaboration.

The themes and contexts in higher education for which the three *C*s are examined include missions and identities, response to external forces, the impact of evaluation systems and ranking schemes, the effects of globalization, intercultural awareness, and gender imbalance, and the challenges of student participation. Statistical tables and visual aids support the analysis and arguments.

This book is the fifth in a series of publications drawn from the annual Forums of the *European Association of Institutional Research (EAIR)* from 2013 onwards.





The authors of this book approach the emergence and endurance of the populist nationalism in post-communist Eastern Europe, with special emphasis on Hungary. They attempt to understand the reasons behind public discourses that increasingly reframe politics in terms of nationhood and nationalism.

Overall, the volume attempts to explain how the new nationalism is rooted in recent political, economic and social processes. The contributors focus on two motifs in public discourse: shift and legacy. Some focus on shifts in public law and shifts in political ethno-nationalism through the lens of constitutional law, while others explain the social and political roots of these shifts. Others discuss the effects of legacy in memory and culture and suggest that both shift and legacy combine to produce the new era of identity politics. Legal experts emphasize that the new Fundamental Law of Hungary is radically different from all previous Hungarian constitutions, and clearly reflects a redefinition of the Hungarian state itself. The authors further examine the role of developments in the fields of sociology and political science that contribute to the kind of politics in which identity is at the fore.





Cleveland, Ohio, has been the U.S. hub for all things related to Hungary and Hungarians since the nineteenth century. Today, Cleveland's Hungarian community remains vibrant and continues to value and preserve its heritage despite the ongoing impact of economic, social and cultural changes, demographic shifts and gentrification. In this work, historian Endre Szentkiralyi examines the concept of "being Hungarian in Cleveland," using a variety of methodologies and drawing on his 47 years as an active member of that community.

He looks at the community historically and sociologically via in-depth research into its language and literature, culture, and traditions, with a focus on the years from 1950 to the present. Today, though Cleveland's unique Hungarian community is shrinking, its extensive roots—significantly shaped by succeeding generations—run deep, and Szentkiralyi's research attests to the fact that it is still thriving. In his conclusion, he addresses recent developments, including the communication and outreach strategies of the community's core organizations, and offers a hopeful outlook for its changing but enduring future.

In recent years, a remarkable flourishing of works on the postwar history of social science and humanities disciplines led to the growing configuration of a field of "Cold War social science" research. Yet in spite of its thematic diversity, and with few exceptions, the geography of the field remains overwhelmingly North American and Western European.

This volume brings in the perspective of the "other Europe." It contributes a series of observations, on and from the margins of the field, which reflect on the condition of knowledge and research on what is perceived and thematized as the (semi-)periphery by the observers themselves. Rather than simply attempting to shift focus, the chapters explore scientific visions of the social off-center. They span the years from the immediate postwar period to the present, and the European semi-peripheries from Tartu to Portugal, with the majority of studies covering East Central Europe.
